



2023/2024 Academy Player Financial Agreement

Each player will be required to pay the following fees to participate in Midwest City Soccer Club's academy program. These fees cover a multitude of expenses which include, but are not limited to: coaching salaries, referee fees, player/club insurance, OSA/USYSA fees, and club maintenance.

The **registration fee** will be charged through Demosphere at time of registration and covers fall & spring seasons.

The **OSA Team Fee** is paid when the team registers in the OSA League.

The **field usage and trainer fee** can be paid by one of three options. A \$15 convenience fee will be charged for payments plans.

- 1- One-time payment of \$650 paid at time of registration.
- 2- Two payments of \$325. First payment August 1st, 2022. Second Payment January 1st, 2023. Must register online in Demosphere with autopay by credit card.
- 3- Monthly payments- Must register online in Demosphere with autopay by Credit Card. 10 monthly payments of \$65 on the first day of each month starting Aug 1st.
Trainer fees may be reduced is a player joins after season has started.

Failure to make monthly payments reduces your coach's monthly salary accordingly. If you don't pay the club, the club can't pay the coach.

Uniforms are purchased at Soccer.com.

Teams may play **Indoor/Futsal** during winter sessions. Payment will be made to team manager.

Each team will play 2-4 **tournaments** per year. Payments of tournaments will be made to the team manager. Tournament payments may include hotel, gas, and meal per-diem for coach. **ALL** rostered players are responsible to pay their part, whether they attend or not.

Once a player is registered as an academy player, the player and parent are committing to the fall & spring seasons (Aug-May) and to all associated fees. Any delinquency in fees associated with the academy program, due their team, or the MWCSC may result in the player or family being placed in "Bad Standing" within MWCSC and/or OSA. Any player that is placed in bad standing CANNOT play for any other OSA team until full payment is made to MWCSC.

If autopay payment has not cleared by the 10th of the month, the player will not be able to attend practices or games until all fees are paid. If no payment is made by the end of the month, the player will be placed in bad standing and removed from the team roster. Per Oklahoma statutes, Title 21 sections 1541.1-1541.4, the club may pursue criminal charges and payments through the Oklahoma County District Attorney. A \$25.00 NSF fee will be added for any payment that is denied due to insufficient funds.
